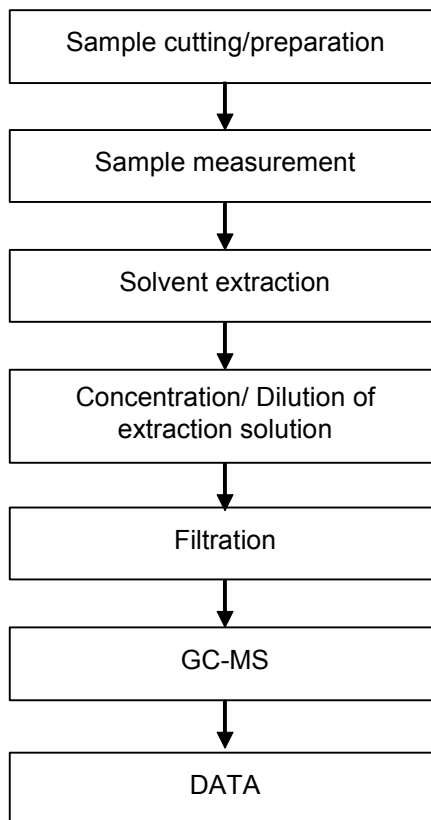

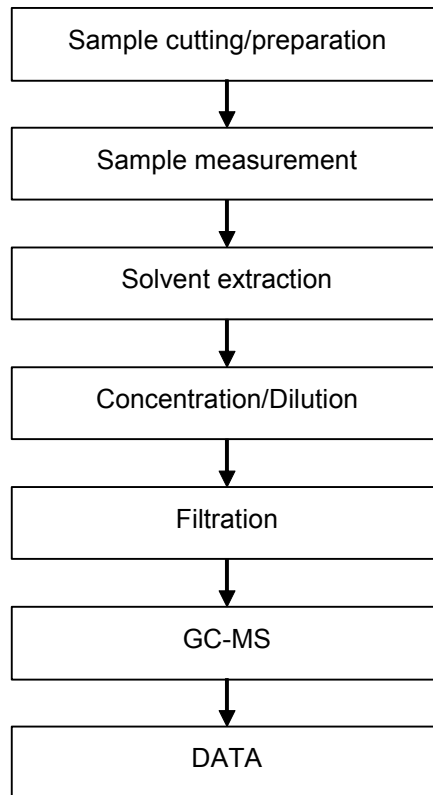

Phthalates Testing Flow Chart

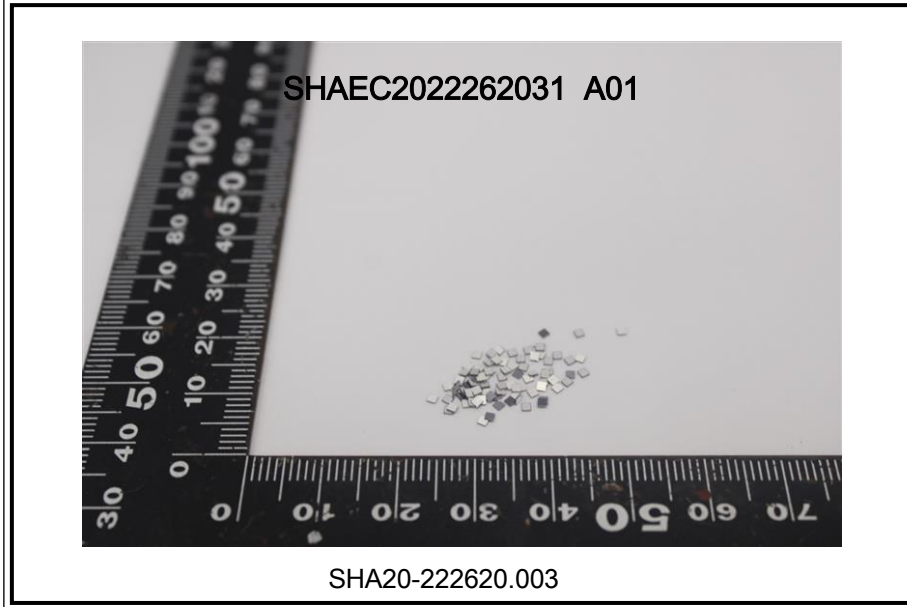

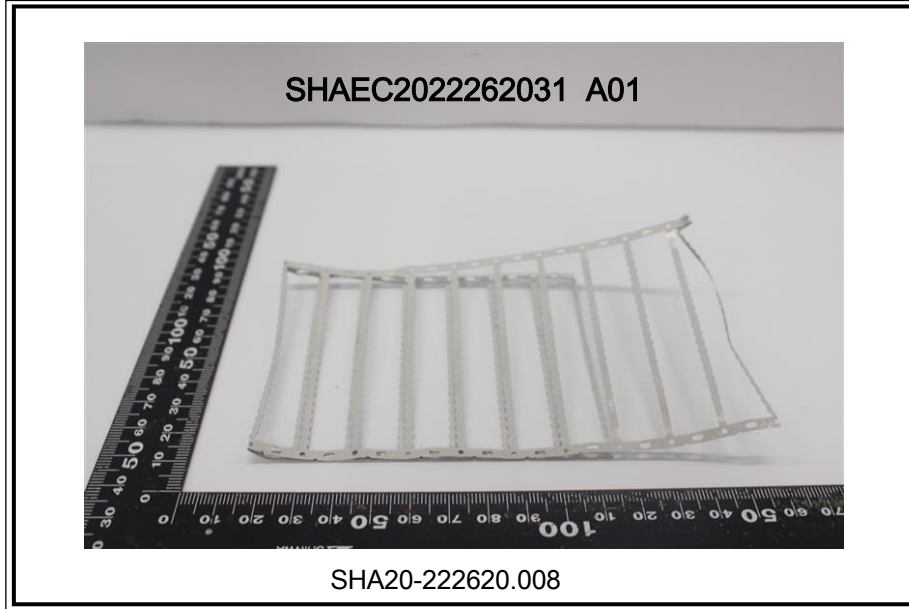
